I/C Secretary, Cane and Bamboo Technology Centre (CBTC) intends to engage the service of reputed firm for construction of **green house for bamboo nursery at Piprakothi, Motihari, Bihar**. The firm should technically capable, financially sound and reliable.

Scope of Work:

The offer for Expression of Interest (EOI) will be through advertisement and interested parties can obtain the application document from the office of Cane and Bamboo Technology Centre (CBTC) for the following scope of works.

1. Construction of Nursery Net Shade House (2m x 10 m)
2. Construction of Compost Shade House (16m x 10m)
3. Construction of Potting Shade House (15m x 10m)
4. Construction of Shade House (15m x 20m)
5. Construction of Compost Shade House (16m x 10m)

*Details drawing of each component are attached

Eligibility for Empanelment:

1. The applicant should be of reputed Agencies/ Firms/ Companies/ Registered Supplier/ organization or Proprietors in India
2. The applicant should have minimum five year experience in the trade or services applied for.
3. The applicant should have *positive profit after tax* for the last three years.
4. The applicant must have an office and/or a service centre in Assam preferably in Guwahati. For authorized distributor the applicant shall produce the supporting document of the authorization. On verification of the information, if at any time the furnished information is found incorrect the empanelment is liable to be cancelled and the firm may be blacklisted

Essential documents:

The following documents (whichever applicable) should accompany with the application:

1. Sales Tax Registration - CST/VAT/TIN No.
2. Trade License, Factory License whichever is applicable.
3. Income Tax - Permanent Account No.
4. Service Tax Registration No. if applicable.
5. For companies - registration certificate from the Registrar of Companies
6. Current dealership agreement in case of Distributors representing a company
7. Audited Statement of Accounts for the last three years.

Application Fee:

The applicant shall submit along with the application a *non-refundable* Application Fee Rs.300.00 in cash or in DD drawn in favour of Cane and Bamboo Technology Centre, payable at Guwahati.

TERMS & CONDITIONS

- A) CBTC's Right to accept/reject any/or all application:
CBTC reserves the right to accept any application and to cancel the empanelment process and reject all applications at any time prior to empanelment or any time after empanelment,
- B) CBTC's right to split the contract:
CBTC reserves the right to split and distribute the work among the registered vendors partly or fully.
- C) CBTC's right to issue clarifications, corrigendum:
If any applicant should find discrepancies or omission in the terms & conditions of the EOI document, or if any clarification is sought, a written request to the tender inviting authority for correction/clarification or interpretation can be submitted 7 days prior to the start date of scrutiny of applications.

Criteria for application rejection/ cancellation of empanelment:

An applicant's application for empanelment or the empanelment of a vendor may be rejected/ cancelled on the following grounds:

1. Any effort by an applicant/ registered vendor to influence CBTC's decisions on evaluation and empanelment process may result in rejection of application or cancellation of empanelment.
2. Applications submitted without or improper application fee(s) or which do not confirm unconditional validity of the application as prescribed or if the information provided by the applicant is found to be incomplete/incorrect /misleading at any stage / time during the empanelment process or thereafter, applications received by CBTC after the last date prescribed for receipt of application or applications without signature of person(s) duly authorized on required pages of the application or applications without power of authorization and any other document consisting of adequate proof of the ability of the signatory to bind the applicant shall be rejected.

3. Manipulation of rates by cartelizations shall be viewed very seriously. If such a situation comes to the notice and/or there are reasons / circumstances for CBTC to believe so, the concerned vendors will be called to give justification of rates quoted by them. If they are not able to give a proper / satisfactory justification of their quoted rates, their empanelment are liable to be cancelled.
4. If the vendors are found, subsequent to their registration, not complying with, any of the eligibility criteria.
5. If a registered vendor has been technically rejected 3 times.
6. If continuous poor performance has been observed for 3 months from a Vendor
7. Any other grounds as decided by CBTC
Such vendors, whose empanelment is cancelled due to any of the above reasons, will not be considered for subsequent empanelment for a minimum period of 3 (three) years.

Other Conditions

1. The vendor's performance on the job will be constantly monitored for quality, commitment to time lines mentioned agreed upon, adherence to the Safety Regulations, Labour/ Statutory regulations, Conduct / Discipline etc., while executing jobs. Any deviations from stated conditions can lead to appropriate deterrent action as deemed fit by CBTC.
2. If the vendor refuses to execute the job at his quoted rates, after work order is issued, he shall be put in holiday list. Vendors shall be issued a warning letter and he shall be debarred from quoting for any jobs for a minimum period of 3 (three) years.
3. CBTC reserves the exclusive right and absolute discretion to call for tenders for any job or otherwise it deems fit, even during the validity of the empanelled period.
4. Successful empanelment by CBTC is no guarantee of any future award of work or inclusion on a particular tender list.
5. If there is any discrepancy in the amount written in words and figures, the amount in words will prevail. If there is any discrepancy in the rate and amount, the figure of rates will be taken into consideration.
6. The other conditions of Contract like delivery timelines, payment milestones, Service Level Agreements, penalties, liquidated damages, etc. will be specific each order and will be decided on a case to case basis.
7. The quality quoted shall not be changed for three years.
